### 1. Introduction

- **Human Resources Related Services:** Learning and development (course delivery and development), employee benefits, talent acquisition, global mobility, and travel services.
- **Marketing:** Creative and production services, event management, translation services, market research, public relations, sales enablement and media.
- **Human Capital:** Contingent labor and consulting.
- **Global Real Estate and Facilities:** Facility management, maintenance and construction, office furniture, asset recovery, and guard services.
- **Customer Facing Services:** Business process outsourcing solutions (sales, tech and care support; hardware break/ fix; global deploy and ICS services; global managed solutions).
- **Technology:** Hardware, such as client devices and peripherals, data center peripherals, network devices and servers.
- **Internal Use Software:** Software associated with business systems, IT systems, and customer service applications, CRMs, LMSs, maintenance support, perpetual licenses, SaaS/ hosted software, and license subscriptions.

### 3. Direct Procurement: Categories of Products and Services Procured

The following are products and services procured in portfolios belonging to the Direct Procurement category:

- **Production Software:** Maintenance and support, OEM/ embedded software licenses, software subscription licenses.
- **Packaging:** Bulk packaging.
- **Processors and Chipsets.**
- **Commodity Procurement:** Circuit boards, batteries, solid-state drives, hard disk drives, memory, LCD screens, flat panel monitors, peripherals and electronic disposition services (excess and obsolescence, asset recovery, disposal and recycling services, and expedites and reworks).
- **Enterprise:**
  - **Telecom:** Radios (Dell and OEM), RF components, ancillaries, CU, DU servers, accelerator cards, 3<sup>rd</sup> party software.
  - **Storage and Networking:** Primary storage, unstructured data storage, HCI/ CI (Hyperconverged Infrastructure/ Converged Infrastructure), mainframe solutions, data protection and management, Connectrix, mechanicals, switches, transceivers.
  - **Servers:** Power Edge, CET (cloud CSP and emerging technologies), PERC (Power Edge Raid Controller) / BOSS (Boot Optimized Server Storage) card, mechanicals.
- **Desktop and Notebooks:** Dell, Dell Pro, Dell Pro Max, Alienware; all non-commodity/processor hardware such as chassis, PSUs, motherboards.
- **Global Materials:** Screws, nuts, bolts, gears, bearings, and pallets.

### 4. Logistics: Categories of Products and Services Procured

The following are products and services procured in portfolios belonging to the Logistics category:

- **S&P Distributors:** 3<sup>rd</sup> party Software and Peripherals (non-Dell products).
- **Outbound/ inbound freight:** Movement of parts and finished goods across various transport methods: LTL, FTL, parcel, ocean and air freight, etc.
- **Fulfillment services:** Services centered around the order fulfillment process. Includes receiving orders, picking and packing products, and shipping them to customers.

- **Contract logistics services:** Warehousing services tailored to a specific need of a business beyond order fulfillment. They can include services such as repairs, returns, packaging and product customization.
- **Trade compliance services:** Customs brokers, importer/exporter agents.
