

Disclosure on all categories in IEEE 1680.1-2018 criteria 4.10.1.1 and 4.10.1.2

Manufacturer shall have a publicly available supplier requirements document (e.g., Supplier Code of Conduct) that addresses major categories of Occupational Health and Safety (OHS) management systems (as defined in OHSAS 18001 and ISO 45001). The manufacturer must also show that each facility meets one or more of the following criteria: 1) certification by a Third-Party accredited Certification Body to OHSAS 18001 or ISO 45001 (certification must be within the last three years). 2) Recognition through the EICC Validated Audit Process (VAP) covering all topics in previous part. 3) Inclusion in an audit program that a) requires full audits every two years by an OHSAS 18001 /ISO 45001 Certified Lead Auditor or an EICC Lead Auditor and b) Includes corrective action identification and resolution.

Dell Technologies assesses factories on a 200-point scale based on performance relative to the RBA Code of Conduct.

We conducted 186 audits at directly contracted supplier factories during the 12-month period August 2022 to July 2023.

The following pages summarize the assessment results and subsequent improvements of low-performing supplier factories and Dell-owned and operated manufacturing facilities.
