## Dell Technologies World 2021 Conference Survey Sweepstakes OFFICIAL RULES

**1. 5. How to Enter: Register for and attend Dell Technologies World 2021, complete the Post-Event Conference Survey, and opt-in to the Sweepstakes on or before the end of the Entry Period. The post-event conference survey will be sent via email to all registered attendees after the conclusion of the event on or around May 7, 2021. The email will include a survey link and each attend will need to enter the same email address they used when registering for Dell Technologies World to complete the survey and opt-in to the Sweepstakes. Only one (1) entry per attendee is allowed.

Use of any automated system to participate is prohibited and will result in disqualification. In the event of a dispute as to any registration, the authorized account holder of the email address used to register will be deemed to be the registrant or player. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. The potential winner may be required to show proof of being the authorized account holder.
