5. How to Enter: An Attendee must complete the badge activity while logged in to the Dell Technology World event on May 5-6, 2021 by following the criteria outlined below.

Badges and completion criteria:

Dell Technologies World Hands-on Badge: Attendee must complete 3 Dell Technologies Hands-On Labs and complete the survey at the end of the Lab by clicking END within the Hands-on Lab to launch the survey, in order to be eligible for the prize drawing.

Use of any automated system to participate is prohibited and will result in disqualification. In the event of a dispute as to any registration, the authorized account holder of the email address used to register will be deemed to be the registrant or player. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. The potential winner may be required to show proof of being the authorized account holder.
